

## CARES ACT APPLICATION FOR U.S. Citizens and Permanent Residents

Application Dates: October 15 through November 1, 2020

The U.S. Federal Government provided emergency relief funds to Dominican University (DU) through the Coronavirus Aid, Relief, Economic Security (CARES) Act. The CARES Act requires DU to disburse funds to **eligible** current students who had specific expenses related to COVID-19. DU will disburse these funds through this application process. If you meet the eligibility requirements below, you should complete this application.

If you meet the eligibility requirements, be sure to complete all pages of this form. An email confirmation will be sent to you once the application has been successfully submitted.

## **ELIGIBILITY FOR CARES ACT FUNDS**

The Federal Government requires that eligibility for CARES Act funds is met based on the following requirements:

- 1. Students must meet the eligibility criteria of Section 484 of the Higher Education Act of 1965, and amended HEA. Section 484 is **generally met** if you successfully filed or were eligible to file a Free Application for Federal Student Aid (FAFSA) form. You must be a United States citizen or permanent resident who is enrolled in a degree seeking program, and are making satisfactory academic progress.
- 2. Eligibility is met if students had specific, related expenses due to COVID-19. These specific expenses include food, housing, technology, course materials, health care and child care. If you had these specific expenses related to COVID-19, you will need to check one or more of the boxes below:

## WHAT HAPPENS NEXT?

Applications for CARES Act funds will be reviewed after the deadline date (November 1, 2020). Your eligibility for participation in Section 484 in Title IV funds of HEA will be verified. If your application is approved, you will receive an email of your approval and the amount. By November 20, 2020, funds will be disbursed to students. The disbursement will be made by echeck\*.

\* An echeck is an electronic check that will be sent to your email address, and will be immediately available to you. You must download to print, or save to copy your echeck, then separately deposit it to your bank account. Echecks will only be sent to DU email addresses.

Special note: DU uses third-party vendor, Paymerang, to process payments. This is an approved vendor should you receive communications from them.
